- Other system settings.

Most browsers give you the option of enabling, restricting, and disabling cookies. If you disable cookies, you may not be able to use all the features of our website or our web services.

The information you submit to us will only be kept as long as needed for the reason it was obtained.

Your Personally Identifiable Information (PII) may be removed from the registry by contacting us. Information, beyond your PII, about the Horses will remain in the registry if we remove your PII

Mailing list information is kept until a user unsubscribes or users requests that we delete that information.

# 6. Updating my Information / User Rights to Information

To update your information with us you must email us or write a letter. The communication needs to specify what information needs to be updated and your sharing preferences.

## 7. Children

This Website is not intended for users under the age of 18. A Parent of Guardian may create a Youth Membership and account for their child's use under their direct supervision only. The user for these accounts is the parent not the child.
